TEAM SPORT AUSTRALIA AWARDS NOMINATION GUIDELINES

- a.** Australian teams will be considered which through their performances have made significant contribution to the nation's sporting heritage and have competed at the highest level of participation available in that sport for that team and in a specific event. For the purposes of this and the next clause 'a specific event' means a single event but may comprise one or more matches or a series of matches for which the team was chosen.
- b.** A team is a combination of two or more players who form a side or unit for the purposes of a specific event.
- c.** Recognition of a team will not confer individual membership on the persons comprising it although those persons may be eligible for nomination for membership by virtue of their individual achievements.
- d.** It is not intended in determining eligibility that the whole of a national team such as for Olympic or Commonwealth Games or Paralympics (the national team being a collection of all disciplines) would be considered. Neither would there be considered the whole of a World Championship Team such as for swimming, athletics, cycling and disabled sports.
- e.** In the case of tennis, Davis Cup teams will be eligible for nomination, but not the squads from which they are chosen. This principle may apply in other disciplines.
- f.** In the case of winning relay teams, athletes who have competed in heats but not finals will not be considered for selection.
